The latest science on masks

Few months back, the latest Cochrane review, the ultimate in evidence based medicine, concluded from a pool of 78 studies, that face masks had no impact on transmission of respiratory viruses including Covid-19, with the use of medical or surgical <u>masks</u>. Even N95 masks did not offer protection from catching the infection.

A more important question is whether they can harm? A detailed <u>systematic review</u> concluded that they can. The summary of available evidence reveals many harms associated with face masks such as progressive lack of oxygen and build up of carbon dioxide, oxidative stress, constriction of blood vessels, inflammatory response, suppression of immunity, and changes at the organ, cellular and microbiome levels. All these can cause mask-induced-exhaustion-syndrome (MIES) which can be misinterpreted as long Covid.

The evidence of the harmful effects of mask use continues to accumulate. A German <u>study</u> concluded that extended masking can result in mild carbon dioxide poisoning and increase risks of stillbirths, testicular dysfunction, and cognitive decline in children adversely impacting their learning.

Study finds association between Covid-19 vaccine and occlusion of retinal blood vessels in eyes leading to visual loss.

A peer reviewed <u>study</u> published in the prestigious Nature group of journals, on 02 May 2023 has found association between Covid-19 vaccines and eye defects leading to diminished vision. The authors concluded that this association is not coincidental.

Class Action Lawsuit in Australian Federal Court - Vaccine injured sue Government Agencies.

A nationwide class action lawsuit in Australia was filed in first week of May 2023, with 500 members seeking redress for persons injured or bereaved due to the COVID-19 vaccines. Naming Australia's national government, the Department of Health and the Therapeutic Goods Administration (TGA) as well as numerous senior bureaucrats in government, members of the class, including a litigant who experienced severe heart damage associated with the Pfizer-BioNTech mRNA COVID-19 vaccine suggest a 'cover up' where health authorities and industry covered up the potential risks associated with the class of vaccine. Filed in New South Wales Federal Court this week, GP Dr. Melissa McCann of Queensland has been a key organizer and fundraiser driving the lawsuit. She secured over \$110,000 via crowdfunding to advance this mass action claiming that the defendants are guilty of negligence due to their approval of the COVID-19 vaccines, as well as breach of statutory

duty and misfeasance in public office.

US have ended Covid-19 vaccination for air travel.

The US declared that International travelers will soon no longer have to show proof of Covid-19 vaccination when arriving in the US. This requirement will be lifted on 11 May 2023. The US was one of the few remaining countries with pandemic travel restrictions in place.

Legal update from India – Court Issues show cause notice to Adar Poonawallah in a Rs 10,000 crores defamation suit.

The Bombay High Court has issued show cause notice and summons to Adar Poonawallah in response to Rs 10,000 crore defamation suit filed by Shri Prakash Pohre, Editor-in-Chief of Deshonnati and senior member of Awaken India Movement (AIM). Former judge Adv Onkar Kakde and National President of Indian Bar Association, Adv Nilesh Ojha are representing the case of Shri Prakash Pohre. Around 500 lawyers from "Indian Lawyers & Human Rights Activists Association," have extended their support to the cause and likely to appear in the case. The injunction by the court sought Serum Institute from claiming that Covishield vaccine is completely safe and making any defamatory and false allegations against members of AIM. Around 3000 new claims of more than 4 lac crores are going to be filed by AIM members across the country against Serum Institute of India, Pune.

Bombay High Court has already issued notice to Adar Poonawallah and Bill Gates in a Rs 1000 crores interim relief petition filed by father of Dr Snehal Lunawat who died due to side effect of Covishield.

Meanwhile the High Pope of Health Declares the Pandemic is Over! Amen!

The Director General of WHO, Tedros Adhanom Ghebreyesus, on 05 May 2023, declared, "It is ... with great hope that I declare COVID-19 over as a global public health emergency."

Vaccines are not working. Adverse effects of the vaccines are surfacing. Litigations are popping up in many countries.
