Dr Sucharit Bhakdi, the renowned virologist, charged for trivializing Covid-19 & misinformation.

Dr Sucharit Bhakdi, Professor Emeritus of Medical Microbiology and Immunology and former Chair, Institute of Medical Microbiology and Hygiene, Johannes Gutenberg University of Mainz, Germany has been charged for trivializing Covid-19 and spreading misinformation. He is facing a hearing in a [German Court](#). We are living in strange times. Instead refuting researchers who hold alternative views by way of data and debate, scientists are being silenced by censorship, court action and by medical councils (Dr Shankara Chetty, who by his protocol, successfully treated thousands of Covid-19 patients in South Africa has been targeted by the [Health Professional Council South Africa](#)).

MSK mRNA vaccines for Pancreatic Cancer

A [statement](#) from Memorial Sloan Kettering Cancer Centre claims that mRNA vaccines are the most

promising things in science now. It wrongly states that these vaccines turned the tide against Covid-19 by *preventing infection*! After overrating the role of mRNA vaccines in Covid-19, the report claims that phase 1 trials of the mRNA vaccine in treatment of pancreatic cancer show promise. The results published in Nature, suggest that the vaccine induced T-Cell immune response in 8 of the 16 patients. These cells can recognize cancer cells and eliminate them. Given the high mortality from this cancer, the five year survival being 5% (Steve Jobs succumbed to it), it would well worth the risk if the results of a large randomized clinical trial in multiple centers show some promise, even if modest. MSK, the manufacturers of the vaccine intend to start enrolling trial participants this summer for the phase 3 trials.

CDC quietly recalls all Johnson and Johnson Vaccines in the USA.

“Janssen COVID-19 Vaccine is no longer available in the U.S. Over 19 million Americans received the Johnson & Johnson “safe and effective” vaccine. The 12.5 million doses in storage are to be immediately destroyed. The health agency did not state why they are recalling [the vaccine](#).

Age of acquiring Smartphone linked to mental health

A large [study](#) involving 27,969 young people has suggested that the age at which they got their first Smartphone or tablet is related to their mental well being. Higher age of getting the Smartphone was associated with better mental health in young people. Smartphone adversely affected their self confidence and ability to interact with others. Younger age of acquiring Smartphone was also linked with suicidal thoughts, hostility towards others and a feeling of being detached from reality. These trends were more in females and consistent across several continents including USA, Australia, Canada, New Zealand, Europe, Africa, Latin America and South Asia. The findings of this study are important for parents, school teachers and educational institutions.

We can infer the monumental mental health impact due to school closures and distance learning through Smartphone/tablets during the pandemic. A whole generation of young people might have been affected for life.

Early age of initiation of sexual activity: misinterpretation of WHO guidelines on sex education?

While recent research shows that Smartphone use at early age is not good, it is common sense that early age of sexual activity should be discouraged as it exposes the child to sexually transmitted diseases, unwanted pregnancies and sexual delinquency. Against this background it sounds unbelievable that the WHO is advising initiation of early sexual activity among children according to a [report](#) by Stop World Control.
