### **Dr Sucharit Bhakdi, the renowned virologist, who was charged for trivializing Covid-19 & spreading misinformation found not guilty by a German court**

A prominent critic of Germany's pandemic restrictions, who was accused of spreading misinformation on Covid-19 and incitement of hatred for Jews, has been acquitted by a German court. The court ruled that the eminent German virologist of Thai origin did not break any law according to [available evidence](#).

We hope that this ruling will give the much needed moral courage to other scientists to defend the science which has been suppressed by corruption, politics and various conflicts of interests these past three years.

The acquittal of Dr Sucharit Bhakdi, did not get any attention from the main stream media, lest people become complacent and do not trust the authorities when they raise a false alarm. Dr Bhakdi's bestseller is named, "Corona False Alarm?"

### **WHO Warns of the Next Pandemic More Deadlier than Covid-19: Fear seems to be the key**

The WHO does not want people to let go of the fear of pandemics. The Director of WHO, Dr Tedros wants to keep the alarm, false or otherwise at high levels. Addressing the World Health Assembly on 22 May 2023, he warned that Covid-19 is far from over, and warned the world to be prepared for the next pandemic which may be "[even deadlier](#)" than the Covid-19 pandemic, whatever that means.

The WHO continues to be vague as ever in its statements. This uncertainty will add to the public panic & facilitate [mass formation psychosis](#). The best way to achieve this to revive the residual panic left in the wake of the pandemic, trivialized by Dr Bhakdi and other courageous scientists who were censored and marginalized. The strategy includes social isolation (one wonders whether 15 minutes cities are part of the plan?), free floating anxiety by threat of "deadlier pandemic," a general sense of unease as a consequence, and free floating psychological discontent. Such communities will be primed to surrender their critical thinking and blindly follow WHO with its dictatorial ambitions in collusion with world governments. The stage seems to be set for the proposed WHO Pandemic Treaty which will hit at the very foundation of democracy, ethics and human rights. ### **The British Heart Foundation has raised alert of increase in abnormal heart beats in the UK**

Atrial fibrillation (flutter of the upper chambers of the heart), have increase from 1 million in 2013 to 1.5 million in 2023, a 50% increase in the UK. This [statement](#) was released on 19 May 2023 by the British Heart Foundation. Atrial fibrillation predisposes to increased incidence of strokes. The rise needs further investigation against the background of myocarditis known to be associated with the Covid-19 vaccines. The British Heart Foundation has not revealed the exact year when the spike in atrial fibrillation has occurred so it is not possible to relate it to the vaccine roll out with this [incomplete data](#).

### **First Covid Vaccine Injury Lawsuit in the USA targets US Govt. & public health officials**

Five vaccine injured persons and a father who lost his 16 year old son due to the Covid-19 vaccine induced cardiac arrest, have [sued](#) the Biden administration and top public health officials for censoring their stories on social media. The litigant also includes a woman who suffered severe nerve damage due to AstraZeneca (Covishield in India). The complainants allege that US government colluded with social medial companies to censor them when they posted their personal vaccine injury experience.

It is a matter of concern that one of the vaccines (AstraZeneca), associated with serious adverse events in the USA and Europe has been used extensively in India for the mass vaccination campaign. We need a thorough survey (by way of “Har Ghar Dastak”), to identify those with adverse events, if any, and compensate them. This is the least we can do to restore peoples’ trust in public health and vaccines.

### **Fortified Rice cleared for mass distribution in haste**

The Prime Minister’s Office ignoring concerns about risk-benefit has cleared fortified rice for [mass distribution](#). This concern was raised recently by the ["reporters collective."](#) Documents accessed by them revealed that most of the pilot projects on the benefits of fortified rice have not taken off at all. The rice is proposed to be fortified with iron to eliminate anemia which is a public health problem in the country. Experts say that fortification is not a long term solution. A diversified diet and adequate food at affordable price is the way to address the problem. Even the Niti-Ayog adviser Anurag Goyal admitted that the pilot projects to test the efficacy of fortified rice were not very successful.

It may be of relevance to recall that in September 2019, the well known periodical “Down to Earth” revealed the beneficiaries from food fortification schemes. The [report](#) published in Down to Earth brought out that rice fortification will create a Rs 3000 crores market for five major companies.

### **Study on credentialed misinformation regarding monkeypox threat**

With the advent of the Internet, human civilization entered the “information age” around the turn of the century. It is however unclear whether we are now in “information age” or “misinformation age”. A recent pre-print [study](#) (yet to be peer-reviewed) does a careful statistical analysis of tweets related to monkeypox among children. The study considered tweets by users with medical credentials (e.g. MD, DO, etc.) in the 5-month period between 18th May to 19th Sep 2022. The authors found:

- as high as 82% of the tweets were *inaccurate*,
- 100% of the tweets *exaggerated* the risk of monkeypox for children
- considering amplification via followers and retweets, twitter users were as much as 974 times more likely to encounter inaccurate rather than accurate information

It is worth remembering that the WHO Director General (Tedros Adhanom Ghebreyesus) too was perhaps guilty of misinformation when in Jul 2022 he had [declared](#) monkeypox as a global public health emergency, while going against the consensus of his own advisers. Therefore, in today’s “information” age, it is all the more important to think critically and question all information, regardless of the source.
