### **Tragic premature deaths of child used as a role model to push Covid-19 Vaccines for children**

An Israeli boy aged 8 years, [died tragically](#) of a heart attack in late September 2023. He was the grandson of a distinguished doctor. He collapsed suddenly while taking a bath and died a few days later in hospital on 28 September 2023. The boy, Yonatan Moshe Erlichman, used to feature in a video to promote the Covid-19 vaccine uptake among children. The video was part of a government program to remove vaccine hesitancy among parents and children even though the virus hardly had any impact on children and most had recovered from natural infection conferring robust immunity [13 times stronger](#) than induced by the vaccine. After the sudden death of the grandson of a distinguished physician, one commentator asked, “How many children will die on the golden altar?”

One swallow does not make a summer. So this isolated case should not be taken as definitive proof of causation. However, there are disturbing patterns of [excess deaths](#) from the Office of National Statistics (ONS) data UK. A scientific approach would be for a proper audit instead of ignoring inconvenient signals. However, most politicians and their advisers who pushed mass vaccination appear to be more interested in saving their skin.

### **Controlling the narrative of vaccine & excess deaths: censor first, if that fails, discount the person**

Throughout the pandemic we saw dissenting scientists even those who presented evidence to substantiate their views being censored. Now we are witnessing another form of narrative control, i.e. challenging the bona fide of those who try to engage in healthy debate and discussion.

On Friday 20<sup>th</sup> October 2023, Andrew Bridgen, an MP, delivered a [speech](#) in the UK Parliament, expressing serious concerns over sustained excess deaths most of which could not be attributed to Covid-19. It took a lot of efforts on his part to bring this debate to Parliament, after 20 attempts. Finally Bridgen was granted 30 minutes to present his case. He addressed an almost empty hall. His speech was supported by data raising concerns about the safety of the Covid jabs, such as recent [reports](#) that the vaccines are contaminated with plasmid DNA above safety limits. His presentation was embarrassing to the proponents of the official narrative who kept parroting that the pandemic measures were necessary and had an impact on controlling the pandemic, and the jabs are safe and effective.

While his speech was blacked out by all mainstream media, the BBC could not resort to this censorship as it is bound to cover the proceedings in the British parliament. To cover the acts of omissions and commissions of the government it resorted to “framing” i.e. using subtitles to discount Andrew Bridgen’s presentation, with captions like, “NHS vaccines do not overload the immune system including vaccines used for children...” “... Government administered vaccines are safe and often essential for public health...” and so on. It also [published](#) a feature by their “Health and disinformation reporter” discounting Bridgen’s speech.

The strategy of such “framing” is to put thoughts in the viewers mind rather than allow for individual critical appraisal of the speaker. This is a psychological technique of propaganda not logic. Such incidences exposes the farce of established democracies under the influence of pharmaceutical industry.

### **Paper giving evidence of massive deaths due to the Covid-19 vaccines exonerated after 7 months**

Scientific journals have not been spared from suppression of facts and censorship in this pandemic. It is a sad state of affairs indeed. [When good science is suppressed people die.](#) Prof Mark Skidmore, wrote a paper in 2021 that over 217,000 Americans may have died due to the Covid-19 vaccination. His paper was promptly retracted

and his institution, the Michigan State University started investigations against him. It is obvious that all attempts were made to discredit him and his academic competence. However, they failed in the efforts and after 7 months his paper has been [republished](#) in a peer reviewed journal.

### **Active surveillance gives a new red alert – increase rates of seizures in toddlers**

A [pre-print](#) reports increase in seizures in young children 2-5 years of age coinciding with rollout of Covid-19 vaccines in children in the USA. The study followed up over 2 million children who had been given the Covid-19 vaccine. While increased rates of myocarditis in older children were reported earlier this study raises a new alert – adverse event on the brain of toddlers manifesting as fits clinically. While febrile convulsions are known in this age group, the incidence of convulsions in the toddlers after rollout of the vaccine was twice than in 2020, the pre-vaccination baseline.

UHO would like to put on record that there are no epidemiological or scientific indications for vaccinating toddlers and children with an experimental vaccine. Children are the most vulnerable group for any short term or long term adverse events. Mass rollout of a vaccine among them for an infection which has zero impact on healthy children amounts to mass scale medical negligence.

### **Draconian Covid-19 lockdowns drove some children and families to despair and contemplate suicide: An audit is recommended**

A public inquiry [inquiry](#) in Scotland brought out the depths of despair some children and families faced due to the draconian lockdown measures. Despair drove some to the brink of suicide according to harrowing testimonies during the public hearings. Legal experts [opined](#) that such harsh measures call for “clear justification and harsh scrutiny.”

The inquiry in Scotland, a tiny country compared to India, has implications for a country which had one of the largest and harshest lockdown in the world at a short notice of 4 hours. On the "[stringency index](#)" developed by University of Oxford, India scored 100 out of 100! The global “philanthropist” Bill Gates [praised](#) India’s proactive measure for “flattening the curve” by imposing the largest lockdown in the world. The WHO also [commended](#) India’s tough and timely lockdown to check transmission of the novel coronavirus.

UHO is concerned that such “praise” from the WHO and the great “philanthropist” Bill Gates, both working in tandem should not prevent the Indian government from carrying out a thorough audit of the unprecedented and harsh measures in public health history. These interventions [violated](#) all principles of public health ethics and human rights. While it did not prevent transmission of the virus, the lockdown and other draconian measures caused huge collateral harm. According to a [report](#) from UNICEF there were 1.5 lakhs excess child deaths due to adverse impact of these interventions. A [commentary](#) in Lancet mentions that such measures are not egalitarian, they kill people by disruption of services and livelihoods. For the poor, recession is not only a matter of having less; it is a matter of life and death. When we lockdown, we cause deaths in the developing world to prolong lives in the developed world the feature mentions. The paper recommends that we must assess lockdowns and other measures holistically remembering that the costs will fall on the global poor.

Such an audit is urgently required as the WHO is in an unholy haste to [push](#) through the Pandemic Treaty and over 300 amendments to the International Health Regulations which will make such harsh & unethical interventions violating human rights standard protocols to deal with future pandemics. The treaty will also jeopardize the sovereignty of 194 member countries of the WHO.

UHO calls on all world governments to put the Pandemic Treaty and amendments to the IHR on hold till a thorough audit of the interventions which causes so much misery, is carried out by an independent body free from any conflicts of interest.
