The Surgeon General of Florida State of USA has called for a complete halt to mRNA vaccines

Last month, the Surgeon General of Florida state of USA wrote a [letter](#) to the Food and Drug Administration (FDA), and the Centre for Disease Control and Prevention (CDC), calling for the halt in the use of Covid-19 mRNA vaccines on grounds that their safety concerns have not been adequately researched in view of billions of particles of DNA discovered per dose of the vaccines. He also expressed concerns about the presence of lipid nanoparticles in the vaccine which are efficient vehicles for carrying these DNA fragments to the cells and tissues.

He pointed out that the FDA itself had issued regulatory limits in 2007 that outlining important considerations for gene based products which have potential to impact human oncogenes which can promote cancers. DNA integration can also lead to chromosomal instability. This could affect different parts of the body such as the heart, brain, kidney, bone marrow, ovaries, testes, lungs, spleen and lymph nodes.

According to the statement released by Surgeon General of Florida, Dr Joseph A Ladapo, “The FDA’s response does not provide data or evidence that the DNA integration assessments they recommended themselves have been performed. Instead, they pointed to genotoxicity studies – which are inadequate assessments for DNA integration risk...”

UHO recommends that it is high time to critically and objectively appraise the safety and efficacy of “the experimental vaccines,” by independent agencies without any conflicts of interests. The FDA in USA is compromised due to the [grants](#) it receives from the pharmaceutical industry. Similarly, the ICMR in India [shares royalty](#) with vaccine manufacturers and has also signed a [declaration of intent](#) with the Gates Foundation for collaboration in research. Such conflicts of interest disqualify the ICMR to critically appraise the safety of the Covid-19 vaccines. The [heavily flawed ICMR study](#) giving a clean chit to the Covid-19 vaccines, should be appraised against this compromised context.

In the Indian context, the mass vaccination rollout had no scientific basis. A [study](#) published in PLOS Medicine showed that by the end of the second wave in June-July 2021 nearly 2/3rd of the Indian population and 85% of health care workers were having IgG antibodies against the Covid-19 virus. At this point of time [less than 10%](#) of Indians were vaccinated. The pandemic had stabilized much before the rollout of the mass vaccination. Had we followed scientific principles we would have saved public money and also averted a large number of adverse events following vaccination.

The New Covid-19 Variant is being made the scapegoat for increase in heart attacks

The new [Covid-19 subvariant JN.1](#) from the lineage of the Omicron variant causes mild and self limiting symptoms. There has been no rise in hospitalization and deaths due to this variant. However, the narrative is being worked up that the JN.1 subvariant can lead to a [global heart failure pandemic](#) based on one Japanese study.

The UHO is concerned that not even science but even history is being distorted in this pandemic to cover up the aftermaths of hastily introduced interventions. Chronologically, heart events including [sudden](#)

[deaths all over the world](#) have been occurring for the past two years much before the emergence of the JN.1 variant. How can the alleged cause, i.e. JN.1 come after the events such as heart events and sudden deaths in the young?

It is well known that in the rarest of rare cases even the common cold [virus can damage the heart](#) muscle (viral myocarditis), therefore the JN.1 virus need not be an exception. But hyping, can create panic and a convenient way to cover up the harm of medical interventions in the long run by distorting the sequence of events as public memory is short.

An elegant study showing changes in the physiology of the heart in the vaccinated is ignored

While there is plenty of media coverage to attribute heart attacks and sudden deaths to all other factors such as lifestyle, sedentary habits, long Covid, the new variant JN.1 and so on, an elegant study [study](#) which showed changes in the physiology of the heart in asymptomatic people who were vaccinated hardly received any media attention. The research published in a peer reviewed medical journal, compared the physiology of the heart among vaccinated and unvaccinated persons.

The investigators compared the glucose uptake of the heart in 303 unvaccinated persons without any heart related symptoms and 700 vaccinated subjects. The study demonstrated that those who had taken the Covid-19 vaccine had much higher glucose uptake by the muscles of the heart compared to the unvaccinated.

The UHO is of the opinion that the implications of this study raise serious concerns and the scientific community and the media should give it the attention it deserves.

Most importantly, the study shows some physiological changes in the heart muscles (myocardium) vaccinated people who did not have overt symptoms. The detection of subclinical myocarditis in asymptomatic persons is a challenge. This study provides a cue towards this end, howsoever faint.

The findings also have an important aspect related to the efficient functioning of the heart. The higher glucose utilization by the heart of those vaccinated is not normal. Heart muscles normally use fat as source of energy for their functioning. Fat is a more efficient fuel for energy compared to glucose. For every unit it gives more than double the energy value. This implies that in the vaccinated person there is less energy reserve for the heart as its fuel is replaced by glucose in place of fat.

Such a heart may function adequately for the average person in his routine daily activities. But strenuous activity by the vaccinated due to the “contaminated fuel” of the heart, can sometimes pose a serious hazard as the heart may not get sufficient energy and may malfunction.

Both the short and long term impact of this calls for detailed study. For this we need our scientists to first acknowledge that they may be a problem with the Covid-19 vaccines. Sadly, there is no such indication. On the contrary, all studies seem to divert attention to other factors which are well known to camouflage the adverse effects on the heart, if any, of the Covid-19 vaccines. The mainstream media is also giving attentions to such red herrings.

UHO recommends that public funds should be allotted to conduct large scale studies, independent of any conflicts of interests, by a team of independent researchers who have no ties with the pharmaceutical industry or organizations like the Gates Foundation which has a narrow perspective of promoting only vaccines instead of overall health and healthy lifestyle. The Gates Foundation also has direct [investments](#) in vaccine production and [antiviral drugs](#) which can influence the perspectives of our policy makers.
