Statistical jugglery by Office of National Statistics (ONS), of the UK, concludes no excess deaths!

The word "Statistics" was <u>derived</u> from the Latin word "status" meaning "political state" or "government." It is a strong weapon is being increasingly misused. While if used properly it can help in planning, implementation and evaluation of welfare measures, used wrongly the state can either inflate government achievements or cover up its blunders. Regrettably, statistics is being used increasingly by world governments for the latter purpose rarely for the former.

As a result, the ability of statistics to give an accurate picture of the world is declining. In this anarchy, a new age of big data controlled by private companies is taking over and endangering democracy.

In recent months concerned citizens and parliamentarians like Andrew Bridgen in the UK have been raising uncomfortable questions about excess deaths in the UK and globally. The excess deaths were starkly evident from the statistics in the public domain put up by the Office of National Statistics (ONS) of the UK.

Instead of conducting a thorough investigation into these excess deaths, the ONS with a stroke of statistical jugglery, have concluded that there are no excess deaths. This feat they achieved by changing the statistical <u>methodology of estimating excess deaths in February 2024</u>. They used extensive mathematical models to obscure and confuse and got the desired results, i.e. <u>all is well and nothing to worry.</u>

UHO is of the view that post-pandemic, we should expect lesser number of vulnerable and the old in the population as the virus targeted them. So during this period any excess deaths particularly in the younger age group as the comparison with baseline data had revealed in most European countries should have been thoroughly investigated instead of covering them us with statistical jugglery.

Similarly, mathematical models stated that the <u>Covid-19 vaccination saved around 20 million lives</u>., while <u>real world data</u> tell a different story.

Statistical jugglery and a flawed paper give Covid-19 vaccines a clean chit in India.

A recent <u>study</u> by the Indian Council of Medical Research (ICMR), with crude statistical jugglery gave a clean chit to the Covid-19 vaccines stating that these vaccines were not linked to the sudden deaths in young people. There were several methodological flaws in this paper which have been brought out by the <u>chairperson</u>, and the <u>secretary</u>, of the UHO.

Largest ever cohort study establishes some "rare" side effects of Covid-19 vaccines

The largest multi-country <u>study</u> so far, which followed up over 99 million vaccinated individuals has confirmed some of the emerging concerns from the vaccines such as myocarditis or inflammation of the heart, pericarditis, Guillain-Barre Syndrome, central nervous system disorders like stroke, cerebral venous thrombosis (due to blood clots), and others. Both the mRNA and the viral vector vaccine (Covishield) were implicated in these serious adverse events which were 1.5 times higher than expected. The data did not include individuals from India, surprisingly, as the country boasted of the largest vaccination drive in the world.

UHO is of the opinion that the ICMR has missed an unique opportunity to launch such a large scale cohort study given our data dividend and large population and huge scale vaccination. Even now this omission can be rectified given our robust CoWin application from which records of vaccinated and unvaccinated persons can be retrieved for follow up. Provided if there is a will to know the uncomfortable truth!

Two of our UHO core committee members, Dr Maya Valecha and Dr Gayatri Panditrao, attended the WHO Pandemic Agreement Civil Society Meetings on 21 Feb 2024. Dr Maya was lucky to get a chance to speak for two minutes in which she packed a lot of punch! She highlighted the low infection fatality rate from the Covid-19 virus, the absence of IgM response after infection with SARS-CoV-2 which indicates that it is not a "novel" coronavirus in real sense but belongs to the family of existing coronaviruses which renders partial immunity to the population due to cross-immunity. "First of all, to understand the issue, I would like to describe the role of WHO during the disease in relation to the vaccine particularly. WHO website itself mentions that Covid IFR was less than 0.05% below the age of 70 years. So, why this so much hue and cry was created for vaccine particularly and other products as well. Why do we want them to take vaccine after all? What we want to say is, does WHO disseminate this real scientific information? People want Nutrition... interruption... Could this be under pharma pressure like Swine-Flu about which already the report had come? So, we do not want Treaty, we do not want vaccine."

Dr Gayatri Panditrao did not get a chance to speak but conveyed her reservations on the Pandemic Treaty on behalf of UHO in the chatbox, and referred to the WHO Director's recent <u>false statement</u>. that the WHO did not impose any restrictions or mandates during the pandemic. She rightly mentioned that the world followed WHO's advice even without any impositions or mandates which caused immense devastations and harm to society. She concluded by mentioning that WHO should be "accountable" for its acts of omission and commissions. UHO does not approve the treaty and be accountable for the misery to the people resulting out of the treaty.
