At last - The Australian Senate admits that the excess deaths call for an inquiry

The Senate in Australia on 26 February 2024 voted in favor of an <u>inquiry</u> into excess deaths in response to persistent efforts by a member Ralph Babet. The Australian Senate had previously rejected three motions on the same issue raised by Ralph Babet.

Excess deaths started in Australia in 2021 and peaked in 2022 continuing into 2023, coinciding with the roll out of Covid vaccines on a mass scale. The latest mortality statistics from Australia show that the mortality remained in excess by 9.9% during the first three quarters in 2023.

While Australia is the first country where the people's representatives have acknowledged the excess deaths, many countries continue to brush the problem under the carpet. For instance, the UK office of National Statistics (ONS), by some <u>statistical jugglery</u> made 20, 000 excess deaths in the UK vanish into thin air.

### Australian court rules that mandatory vaccination of essential workers was unlawful and violation of human rights

The <u>Queensland Supreme Court has found</u> mandatory COVID-19 vaccination for police officers and nurses was unlawful and in breach of their human rights. The ruling has been described as a huge legal victory for front-line workers who lost their jobs over their refusal to be vaccinated. Dozens of police officers and healthcare workers have been vindicated in a 115-page judgment.

Justice Glenn Martin remarked dissatisfaction with the Police Commissioner lacking proper consideration for the human rights of her employees. 74 court cases were financed by billionaire Clive Palmer who called for celebration after the court's decisions, calling it the "first precedent of the Western world".

#### A Top Cardiologist calls for investigation on huge rise in myocarditis in young people

Dr Dean Patterson, a leading English Cardiologist, <u>has written to the General Medical Council</u> (GMC) of the UK, to investigate the harms from the Covid-19 vaccines. In the letter narrated the high number of myocarditis cases post vaccination he is witnessing in his practice and spoke in support of another leading cardiologist Dr Aseem Malhotra who has been acting as a whistleblower trying to draw attention of the world medical community to the link between the Covid-19 vaccines and heart attacks.

In fact the letter to the GMC first appeared on Dr Aseem Malhotra's blog. Dr Aseem Malhotra, also visited India last year in February and attended the inauguration ceremony of the Universal Health Organization (UHO) at New Delhi. During this visit he <a href="had issued a warning">had issued a warning</a> on the Covishield vaccine which was used in the mass vaccination campaign in the country, stating that this vaccine had more serious adverse effects compared to the mRNA vaccines.

UHO recommends further research on the safety and efficacy of the Covid-19 vaccines and a calibrated risk-benefit approach in future strategies for vaccine rollout which was neglected in the Covid-19 pandemic. Even young and healthy people with negligible risk from the virus and also those who had recovered from the natural infection which studies show had strong immunity were compelled and coerced to take the vaccine. Any serious adverse events or deaths in these low risk groups are unacceptable.

#### Race to develop rapid testing kits for two of the world's deadliest pathogens

Scientists are racing to develop <u>rapid testing kits for two "deadly" viruses</u>. Nipah and Lassa fever virus. Both are endemic in wild life. These may have existed in the animal kingdom for ages and occasionally lead to sporadic outbreaks when humans come in contact with fruit bat contaminated fruits in case of Nipah or food contaminated by rats in case of Lassa fever.

While Nipah occurs in South East Asia region, Lassa fever is confined to African continent with more than 80% cases being asymptomatic. Scientists do not know exactly how widespread is Lassa fever. It may be recalled that few months ago there was a Nipah scare in Kerala, India on occurrence of handful of cases and one death which did not progress further. While the virus may 70% fatality rate it has low potential for transmission can causing large scale outbreaks. Any virus with a high fatality or which causes severe symptoms does not travel far as it perishes with the victim or the patient goes into isolation leading to a dead end infection.

Viruses and pathogens have existed in nature and in the animal kingdom 3.5 billion years before humans evolved and may perhaps outlive us. Nature facilitates equilibrium by way of a symbiotic relationship between higher life forms which include humans and pathogens.

The development of testing kits for these viruses has received \$14.9 million from Coalition of Epidemic Preparedness and Innovation (CEPI). A spokesperson said that the plan aims to develop rapid test kits and 100 prototype vaccines for the 25 viral families currently known to infect humans. He said that the project was also critical to promote the "100 Days Mission" of CEPI, i.e. to produce a vaccine in 100 days in which \$3.5 billion have been invested for the next five years. The project is also backed by G7 and G20.

It is relevant to know the background of CEPI which has headquarters in Oslo, Norway. This is an organization that receives funds from public, private, philanthropic and civil society organizations. Its main priority is to develop vaccines within 100 days against emerging infectious diseases and pandemics. CEPI was conceived in 2015 and formally launched in 2017 at the World Economic Forum in Switzerland. It was the brainchild of Jeremy Farrar, the present Chief Scientific Officer of the WHO. It was co-founded and co-funded with \$460 million by the Gates Foundation and the Wellcome Trust, both private players. Jeremy Farrar has also worked for the Wellcome trust in the past. Recently the Serum Institute of India, Pune also has partnered with CEPI to develop a vaccine against Disease X within 100 days.

UHO is seriously concerned with all these sinister developments. Appointment of Farrar who has strong ties with the pharmaceutical industry and a narrow vision of controlling pandemics focusing

solely on vaccines without fully understanding the epidemiology of communicable diseases does not bode well for humanity. Besides such a narrow policy and plan to develop and deploy vaccines in 100 days is shortsighted and can be disastrous.

Against these developments the final nail in the coffin for humanity would be the WHO Pandemic Treaty and the amendments to the International Health Regulations (IHR), if they come in force. The future looks gloomy if the world community does not wake up and expose the various conflicts of interests which have contaminated the WHO.

Once people are empowered they can force their governments to come out of the clutches of the WHO and its vested interest groups. Billions of dollars which are being invested in developing vaccines in 100 days with uncertain efficacy and safety (no vaccine can clear these bars in such a short time), can be diverted for nutritious food and hygiene for the people. No pathogen can affect healthy populations. Few elites just by owning the wealth of the world cannot decide how its resources should be utilized. Decentralized decision making is the need of the hour.
