### **British MP Andrew Bridgen makes public a complaint he lodged with the police asking for a criminal investigation on Covid-19 pandemic and vaccine rollout**

Rishi Sunak British Prime Minister may face a criminal investigation. ### **More pressure on the UK Government – MPs ask Health Secretary to release data that may link Covid-19 vaccine with excess deaths**

### **Sinister developments: Avian Influenza a potential agent for a future pandemic?**

The mainstream medical community seems to be scratching the bottom in a desperate attempt to declare the next pandemic. A [computer model called EPINEST](#) is being used to map and track avian influenza virus spread across the globe.

Scientists across disciplines working on the “One Health” project have developed a modeling framework to track pathogens as they spread from poultry and livestock and into humans, from “farm to fork.”

What is concerning is that the model was developed and tested by tracking the spread of avian influenza (bird flu) through a network of farms, markets and transport system of broiler chickens in Bangladesh.

Avian influenza or bird flu is being constantly projected as a potential infection for future pandemics. UHO is apprehensive that a misleading mathematical model may be used to declare the next pandemic of bird flu and spread worldwide panic as the Imperial College of London model did in the case of SARS-CoV-2. Mathematical models should be used only for academic exercises and not for policy planning and pandemic control as the shelf life of the best models are not more than two weeks due to the dynamics of infectious disease epidemiology. Mathematical models cannot replace meticulous field epidemiology. While UHO does recommend continuous surveillance and monitoring of infectious disease spread by regular compilation of accurate field data, it has serious reservations about mathematical models guiding public health policy.

The plot thickens when one considers that more than a decade ago the Avian Influenza Virus H5N1 was subjected to the [hazardous “Gain-of-Function” research](#). This type of research “amplifies” the “function” of a virus by lab experiments to make it more transmissible, increase its virulence or make it infect a new host. This type of research is ostensibly to develop vaccines in case the virus mutates but responsible scientists have expressed serious concerns about “Gain-of-Function” research as it can pose serious and uncertain hazards to humans by accidental or deliberate lab leaks.

Due to such concerns by responsible scientists, the “Gain-of-Function” research with the H5N1 bird flu virus was ceased in the year 2012. The moratorium was signed by forty leading influenza researchers from the USA, China, Japan, Hong Kong, UK, Germany, Italy, Canada and The Netherlands. A number of stakeholders are involved in the Gain of Function research. While the purpose of the moratorium was to take time to carry out the risk-benefit analysis of this type of research, it is believed that the temporary halt was planned to gain public acceptance for this type of research. The moratorium was lifted in the year 2013.

UHO strongly recommends a complete ban on “Gain-of-Function” research due to its hazardous nature. It also fears that this type of research will lead to a “biological arms race,” triggering a global “pharma race” by controlled release of engineered viruses and promotion of vaccines developed against pathogens enhanced by Gain-of-Function research. It is relevant to state that a human vaccine [against H5N1 is being developed](#) for the past decade. In the proposed amendments to the International Health Regulations as part of the proposed WHO Pandemic Treaty there is a provision for getting countries to share pathogens with the WHO. It is now quite obvious that the [WHO is on a power grab mission](#) and missing this fine print can have grave consequences endangering humanity in case certain nations and the unscrupulous WHO carries out Gain-of-Function research with these pathogens.

In the context of these developments, the interest of the mainstream medical community in computer simulation of H5N1 pandemics on the EPINEST platform is ominous. According to some scientists, the SARS-CoV-2 pandemic also evolved after a lab leak but others are equally confident it evolved from an animal source at the wet market in Wuhan. According to a [commentary in the BMJ](#), both the possibilities are plausible and most scientists are resigned that the truth will never be known. Whatever the origins of the Wuhan virus, faulty mathematical models which predicted doomsday led to panic and hasty decisions causing immense misery as a result of draconian interventions. Does it ring a bell? Will mathematical models again misguide the world?
